

**2024-25 ATLANTA HAWKS-EMORY HEALTHCARE SUITE SWEEPSTAKES (“SWEEPSTAKES”)
OFFICIAL RULES AND REGULATIONS
NO PURCHASE NECESSARY**

- **ELIGIBILITY.** **NO PURCHASE NECESSARY** to enter or win. The 2024-25 Atlanta Hawks-Emory Healthcare Suite Sweepstakes (the “Sweepstakes”) is open only to legal residents of the state of Georgia and the United States, who as of the date of their Entry (defined below) into the Sweepstakes are at least eighteen (18) years of age, reside within 150 miles of the corporate limits of Atlanta, Georgia and have internet access as of **9:00 AM EST December 2, 2024**, the date and time the Sweepstakes is first made known to the public. Employees and their immediate family members (spouses, parents, legal guardians, in-laws, grandparents, siblings, children, household members and the spouses and children of the foregoing) of Sponsors (as defined below), and ATL Hawks, LLC, Atlanta Hawks Management, LLC, Arena Sports Marketing, LLC, Arena Operations, LLC d/b/a State Farm Arena, The National Basketball Association and its Member Teams, NBA Properties, Inc., NBA Media Ventures, LLC (the “NBA” or “NBA Entities”), and each of their respective parents, subsidiaries, divisions, directors, officers, members, partners, trustees, franchisees, governors, agents, owners, shareholders, participating vendors, distributors, advertising and promotion agencies and affiliated entities’ employees and each of their respective families (spouses, parents, legal guardians, in-laws, grandparents, siblings, children, household members and the spouses and children of the foregoing) (collectively, the “Sweepstakes Entities”) are not eligible to enter the Sweepstakes. Some restrictions apply. By entering the Sweepstakes, participants agree to accept and be bound by all terms of these Official Rules and Regulations. The Sweepstakes are subject to all federal, state and local laws and regulations. Free internet access is available at many public libraries. Void wherever prohibited or restricted by law.

- **HOW TO ENTER.** Sweepstakes runs from **9:00 AM EST December 2, 2024 – 11:59 PM EST December 16, 2024** (the “Sweepstakes Period”). There will be two (2) methods of entry. Throughout the Sweepstakes Period, there will be one (1) entry period (the “Entry Period”). During the Entry Period, eligible individuals can either: (1) go online, fill out, and submit a completed entry form located at www.hawks.com/emorysweeps and click the 2024-25 Atlanta Hawks-Emory Healthcare Suite Sweepstakes icon to retrieve the entry form, complete the entry form in its entirety, which will include name, e-mail address, physical mailing address, date of birth and an opt-in to receive communications from Sponsors, then submit the entry form by clicking the “submit” button on the entry form page (each, an “Entrant”) or (2) if an Entrant does not wish to receive communications from Sponsors, Entrants may (at their own cost) mail-in a completed entry form in its entirety, which will include name, e-mail address, physical mailing address and date of birth to Atlanta Hawks, Attn: Emory Suite Sweepstakes, 101 Marietta Street NW, Suite 1900, Atlanta, GA 30303. **Limit one (1) entry per person or email address.** Entrants must enter in their own name and not on behalf of or

for anyone else. In the event of a dispute about the identity of an online entrant, each online entry will be declared made by the authorized account holder of the email address submitted at the time of entry as determined by Sponsors. The potential winner may be required to provide Sponsors with proof that he/she is the authorized account holder of the email address associated with the winning entry. By entering, you are signing up for both the Atlanta Hawks database to receive Atlanta Hawks email updates for promotional offers, products and events and the Emory database to receive email and mailing updates for promotional offers, services, health newsletters and events. Such information shall be maintained in accordance with the Atlanta Hawks and Emory privacy policies.

No mechanical reproductions or facsimiles accepted. Sponsors are not responsible for misdirected, incomplete, lost, late or illegible entries, technical, hardware or software failures of any kind, lost or unavailable network connections, or failed, incomplete, garbled or delayed computer transmissions or other errors or problems which may limit a participant's ability to participate in the Sweepstakes or damage to a user's system as a result of participation in the Sweepstakes or downloading of any information necessary to participate in the Sweepstakes. False or deceptive entries or acts, as determined by Sponsors, will render the entrant ineligible. Sponsors reserve the right, in their sole discretion, to cancel or modify the Sweepstakes should any computer virus, malfunction or other cause beyond their control corrupt the administration, security or proper operation of the Sweepstakes. All entries become the property of Sponsors and will not be returned. All entries must be submitted in the name of an individual person and prizes can only be awarded to the person whose name is on or corresponds to each winning entry. **LIMIT ONE ENTRY PER PERSON.** Attempts to enter the Sweepstakes more than once may disqualify entries from the Sweepstakes.

- **HOW TO WIN.** One (1) winner (the "Winner") will be selected in a random drawing conducted on or about December 17, 2024 from among all eligible Entries received during the Entry Period by representatives of the Sponsors. Full description of prizes is listed below. The odds of winning will be determined by the number of eligible entries received. Sweepstakes will be administered by the Sponsors, decisions of which in all matters regarding the Sweepstakes shall be final and binding. Each Winner will be notified by telephone or email, and must meet all eligibility requirements including the execution and delivery of all necessary releases, including an Affidavit of Eligibility/Release of Liability and Publicity Release form and a completed tax acknowledgment form within three (3) days of date of issuance. A Winner's failure to return all required forms in this three (3) day time period may result in the Winner being disqualified and an alternate winner may or may not be selected at Sponsors' sole discretion. If a dispute arises regarding who submitted an on-line entry, the entry will be deemed submitted by the holder of the email account as determined by Sponsors. However, if delays in obtaining the necessary releases would make it impracticable to select another Winner due to the timing of the use of one of the prizes, no alternative Winner will be awarded. If the Winner does not respond within twenty-four (24) hours after the first attempt to contact him/her, Sponsors may select an alternate in his/her place at random from all eligible entries received.

- **PRIZES.** One (1) Winner will receive ten (10) tickets to sit in the Sharecare Social Cabana Suite, including food and beverage, and two (2) parking passes at the December 23, 2024 Atlanta Hawks home game at State Farm Arena vs. the Minnesota Timberwolves (the “Game”) with a total AMV of all prizes of \$2992.50 (the “Prize”). Note that the exact seat location of the tickets for the Game shall be chosen at Sponsors’ sole discretion and will be subject in all cases to availability. No resell or transfer. The reporting and payment of any tax liabilities incurred by the entrant as a result of this Sweepstakes and any prize(s) won are the sole responsibility of the entrant. No substitution or transfer of prize(s) or cash redemptions permitted by Winner. The Sweepstakes Entities reserve the right to substitute a prize of like value in the event the described prize, or any portion thereof, is unavailable for any reason whatsoever. Prize is non-transferable and non-assignable. No prize substitution allowed by winner. No portion of the prize may be sold, bartered or exchanged by the winner. If awarded, Prize will be awarded without any warranty of any kind beyond manufacturer’s standard warranty. Sponsors are not responsible if the Game is delayed, postponed or cancelled for any reason and winner will not be reimbursed for tickets. Tickets may be subject to issuer’s standard rain-check policies and procedures. Headings are solely for convenience of reference and will not be deemed to affect in any manner the meaning or intent of the documents or any provision hereof. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in any Sweepstakes-related materials, privacy policy or terms of use on the Entry Site and/or the terms and conditions of the Official Rules, the Official Rules shall prevail, govern and control and the discrepancy will be resolved in Sponsors' sole and absolute discretion.
