

2026 Celtics Perfect Putter Sweepstakes presented by JetBlue

Official Rules

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW. PRIZE ACCEPTANCE RELEASE IS REQUIRED.

1. Eligibility. The “2026 Celtics Perfect Putter Sweepstakes presented by JetBlue” (the “Sweepstakes”) is only open to legal residents of the U.S., who, at the time of entry, are (a) eighteen (18) years of age or older; and (b) residents of (i) Massachusetts, (ii) New Hampshire, Vermont, and Maine who live within a one hundred fifty (150) mile radius of Boston, Massachusetts, or (iii) Connecticut who live within a seventy-five (75) mile radius of Boston, Massachusetts. Employees, household members (legally related or not) of employees, and the immediate family members (*i.e.*, spouses, parents, legal-guardians, in-laws, siblings, grandparents, grandchildren and children) of employees of the following entities are not eligible to enter this Sweepstakes: (1) Banner Seventeen, LLC, doing business as the Boston Celtics (“Celtics”), (2) the National Basketball Association (“NBA”) and its Member Teams, (3) NBA Properties, Inc., (4) JetBlue Airways Corporation, and/or any of the respective parents, subsidiaries, affiliates, employees, directors, officers, governors, owners, advertising and promotion agencies, representatives and agents of any of the foregoing entities. In these Sweepstakes rules (the “Official Rules”), the above entities numbered (1)-(3), and their respective parents, subsidiaries, affiliates, directors, officers, governors, owners, advertising agencies, promotion agencies, and agents, are collectively referred to as the “NBA Entities,” and the entity numbered (4), and their respective parents, subsidiaries, affiliates, employees, directors, officers, governors, owners, advertising agencies, promotion agencies, and agents, are collectively referred to as “JetBlue.” By entering this Sweepstakes, each entrant represents and warrants that entrant meets the above eligibility requirements and agrees to abide by these Official Rules.
2. Time for and Method of Entry. The entry period for the Sweepstakes (“Entry Period”) will begin at 12:00 p.m. Eastern Time (“ET”) on August 13, 2026, and will end at 12:00 p.m. ET on August 27, 2026. No entries will be accepted after 12:00 p.m. ET on August 27, 2026.

There is one (1) method of entry for the Sweepstakes, as follows:

Completely fill out and submit the Sweepstakes entry form (“Entry Form”) electronically online at [Celtics.com/schedulereleasesweeps](https://celtics.com/schedulereleasesweeps) (“Entry Website”). Once the Entry Form is successfully completed and submitted, its entrant will be automatically entered to win the prize described in Section 4.

LIMIT ONE (1) ENTRY PER PERSON. Subsequent attempts made by the same individual to submit multiple entries by using multiple or false contact information, multiple e-mail accounts, multiple phone numbers, or otherwise, may be disqualified. Mechanically reproduced entries may be disqualified. Entries generated by a script, computer programs, macro, programmed, robotic or other automated means are void and may be disqualified. The Sponsors (as defined in Section 11) are not responsible for lost, late, incomplete, inaccurate, forged, mass-reproduced or mass-transmitted, mutilated, stolen, destroyed, invalid, delayed, unintelligible, misdirected, technically corrupted, undelivered or garbled electronic entries; and such entries are void. The Sponsors are not responsible for lost, interrupted or unavailable network, server, Internet Service Provider (“ISP”), website, or other connections, availability or accessibility, or miscommunications, unavailability of the Entry Website service or e-mail account access or verification issues, or failed computer, satellite, telephone, or cable transmissions, lines, or viruses or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, undelivered or improperly formatted entries (including Entry Form), failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors or difficulties which may occur in connection with the administration of the Sweepstakes, the processing of entries, failures on the part of the Entry Website or any Entry Website search function failure that prevents the Celtics from receiving and/or viewing entries, the announcement of any prizes, in any Sweepstakes-related materials, or the cancellation or postponement of the Sweepstakes. For purposes of this Sweepstakes, an online entry is “received” when the Entry Website’s servers record the entry information. Proof of sending (such as an automated computer receipt confirming entry or

“thanks for entering” message) does not constitute proof of actual receipt of an entry for purposes of this Sweepstakes. The Entry Website’s database clock timestamps will be the official timekeeper for this Sweepstakes. Illegible and/or incomplete entries and entries submitted by entrants who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void. Those who do not follow all of the instructions, provide the required information in their Entry Form, or abide by these Official Rules or other instructions of the Sponsors may be disqualified.

The Sponsors are not responsible for the actions of entrants in connection with the Sweepstakes, including entrants’ attempts to circumvent the Official Rules or otherwise interfere with the administration, security, fairness, integrity or proper conduct of the Sweepstakes. Persons found tampering with or abusing any aspect of this Sweepstakes, or whom the Sponsors believe to be causing malfunction, error, disruption or damage may be disqualified. Additionally, any attempt to cheat the Sweepstakes, as determined at the sole and absolute discretion of the Sponsor, may result in immediate disqualification of the entrant, as well as other possible consequences, including disqualification from any and all existing and future Celtics contests or sweepstakes of the Sponsor. ANY ATTEMPT BY A PERSON TO DAMAGE ANY WEBSITE (INCLUDING THE ENTRY WEBSITE OR SERVER), OR UNDERMINE THE LEGITIMATE OPERATION OF THIS SWEEPSTAKES MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, THE SPONSORS RESERVE THE RIGHT TO SEEK ALL LEGAL AND EQUITABLE REMEDIES FROM AND AGAINST ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW, INCLUDING CRIMINAL PROSECUTION. The Sponsors reserve the right, in its sole and absolute discretion, to disqualify (or terminate the prize of) any individual who is found to be, or suspected of, acting in violation of these Official Rules, or to be acting in an unsportsmanlike, obscene, immoral or disruptive manner, or with the intent to annoy, abuse, threaten or harass any other person.

3. Prize Rules. The Sponsors reserve the right, in their sole discretion, to modify, suspend, or terminate the Sweepstakes (or any portion thereof), or take any other action deemed necessary, should any virus, bugs, non-authorized human intervention or other causes beyond the reasonable control of the Sponsor, including, but not limited to, applicable law, regulation, or government action related to the COVID-19 pandemic, war or armed conflict (whether or not officially declared), labor controversy or threat thereof, and/or acts of God, corrupt or impair the administration, security, fairness or proper play of the Sweepstakes and, in the event of termination or suspension, in their sole discretion, the Sponsors may select the Prize Winner (as defined in Section 4) for the Sweepstakes from among all eligible, non-suspect entries received as of the date of the event requiring such termination or suspension. By participating in this Sweepstakes, each entrant agrees to be bound by these Official Rules, and the decisions of the Sponsor, which are final and binding in all respects. Failure to abide by these Official Rules may result in disqualification. All materials submitted become the property of the Sponsors and will not be returned. In the event of a dispute over the identity of an entrant, entry will be deemed submitted by the registered account holder of the e-mail address associated with the entry for the domain associated with the submitted address, provided that person is eligible. The Prize Winner may be required to show proof of being the registered account holder. Registered account holder is defined as the person assigned to an e-mail address by an Internet access provider, on-line service provider or other organization responsible for assigning e-mail addresses. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to the Sponsor’s satisfaction, the affected entry will be deemed ineligible. The Sponsors are not responsible for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, or insufficient space in entrant’s account to receive messages, or e-mail account to receive e-mail messages. The Sponsors are also not responsible for any failure of the Entry Website service or other event that otherwise prevents the Sponsors from accepting an entry.

The prize is not transferable, and no substitutions or cash redemptions are allowed, except by the Sponsors, who reserves the right to substitute a prize (or component thereof) with one of comparable or greater retail value, in their sole discretion. All costs and expenses not stated herein as being provided in connection with the redemption, receipt and/or use of the prize are the responsibility of the Prize Winner, including, without limitation, transportation. All prize details are at the Sponsors’ sole discretion. Prize details and availability are subject to change and prize provider’s rules and restrictions, and in the event that the Sponsors is unable to provide the Prize Winner with his/her prize, the Sponsors may elect to provide the Prize Winner with the approximate value of such item in cash or award an alternate prize of comparable or greater value. Unclaimed prizes will be forfeited.

4. Prize Winner Selection and Notification. There will be one (1) winner of the prize described below (the “Prize Winner”). The Prize Winner will be selected by random drawing on or around August 28, 2026, from among all eligible entries received during the Entry Period.

The Prize Winner will receive: (a) one (1) Celtics-branded golf putter, with the specific putter to be determined by the Sponsors in their sole discretion (approximate retail value (“ARV”) \$250.00); (b) two (2) JetBlue core travel certificates to be used towards commercial air transportation by JetBlue for the Prize Winner, subject to the restrictions set forth in Section 5 below (ARV \$500.00); (c) one (1) JetBlue-branded towel, with the specific towel to be determined by the Sponsors in their sole discretion (ARV \$40.00); (d) one (1) JetBlue-branded bag, with the specific bag to be determined by the Sponsors in their sole discretion (ARV \$20.00); and (e) one (1) JetBlue-branded hat, with the specific hat to be determined by the Sponsors in their sole discretion (ARV \$30.00). The total ARV of the prize is \$840.00.

The entrant selected as the Prize Winner will be notified by mobile phone number and/or e-mail within a reasonable time following the drawing. It is the sole responsibility of each entrant to notify the Sponsor if his or her contact information changes. The Sponsors are not responsible for false, incorrect, changed, incomplete, or illegible contact information. The entrant who is selected as the Prize Winner must respond to the Sponsors within forty-eight (48) hours of receiving notice. In the event an entrant who is selected as winner cannot be contacted or does not respond within forty-eight (48) hours, or declines the prize, another winner will be selected using the same criteria under this Section.

5. Additional Prize Terms. The Prize Winner is solely responsible for all applicable federal, state and local taxes and any expenses associated with any prize he or she receives, including any required advance withholding payments. An IRS Form 1099 or IRS Form W2G may be issued in the name of the Prize Winner for the actual value of the prize received. The Prize Winner must show a photo ID upon the Sponsors’ request to redeem the prize.

Winners are responsible for any loss of prize or portion of prize after prize has been booked or credit has been awarded. The Sponsors will not replace any lost or stolen prizes. The Prize Winner and one (1) guest’s air travel must take place within one (1) year of prize award. For all certificate details, see http://www.jetblue.com/p/jetblue_coc.pdf. Travel certificate is subject to Terms and Conditions, availability, blackout dates, capacity controls and seat availability. Travel certificate is not transferable, once redeemed; name changes are not permitted; however, at no time may it be purchased, sold, bartered, traded on an auction website or otherwise exchanged for value without prior written consent from JetBlue. Travel certificate cannot be partially redeemed, is not redeemable for cash, and has no cash value. Redeemed travel is not eligible for TrueBlue points. (TrueBlue is JetBlue’s loyalty program). JetBlue’s change/cancel policies (including any applicable certain change/cancel fees) apply. If any First Prize Winner is a no-show for reserved flight or does not change/cancel prior to scheduled departure, such First Prize Winner will forfeit the First Prize and the value of the travel certificate associated with the reservation. Any additional travel expenses such as hotel accommodations, ground transportation, gratuities, luggage fees, meals and incidental charges) related to acceptance and uses of the prize not specifically stated herein are the sole responsibility of each First Prize Winner. First Prize Winners must possess valid travel documents (i.e., a valid government-issued identification or passport, etc., as applicable) in order to travel. First Prize Winners are responsible for obtaining travel insurance (and all other forms of insurance) at their option and hereby acknowledge that Sponsor has not and will not obtain or provide travel insurance or any other form of insurance. No refund or compensation will be made in the event of the cancellation or delay of any flight except at the sole discretion of Sponsor. Sponsor, Administrator, NBA Entities, and any other Released Parties shall not be responsible for any cancellations, delays, diversions or substitutions or any act or omissions whatsoever by any air carriers or other transportation companies or any other persons providing any of these services to passengers including any results thereof such as changes in services or accommodations necessitated by same. The passenger contracts in use by the JetBlue shall constitute the sole contracts with respect to each First Prize Winner's transportation and such contracts shall be solely between the Grand Prize winner and Sponsor. Each First Prize Winner must also follow any applicable COVID protocols in place at time of traveling. In the event that any First Prize Winner engages in behavior during travel that (as determined by Sponsor in its sole discretion) is obnoxious or threatening, illegal, or that is intended to threaten or harass any other person, or that in any way disparages or adversely affects the

reputation, image, and/or customer goodwill of any Released Party, and Sponsor, Administrator reserve the right to terminate the travel early, and send such First Prize Winner home (at winner's own expense) with no further obligations or compensation whatsoever to the First Prize Winner (which may, in Sponsor's sole discretion, result in the First Prize Winner's disqualification from the Sweepstakes and forfeiture of prize). In the event any First Prize Winner engages in behavior during travel that (as determined by Sponsor in its sole discretion) is illegal, tortious, or subjects that prize winner to arrest or detention, the Released Parties shall have no obligation to pay any damages, fees, fines, judgments or other costs or expenses of any kind whatsoever incurred by prize winner as a result of such conduct.

The Sponsors will not be responsible for awarding any un-awarded portion of a prize to a Prize Winner if a Prize Winner undertakes activities or communicates messages or images or engages in speech publicly or made known publicly that: (a) are sexually explicit, unnecessarily violent or derogatory of any ethnic, racial, gender, religious, professional or age group; (b) are obscene or offensive, or may create public disrepute, contempt, scandal or ridicule; (c) defame or invade publicity rights or privacy of any person, living or deceased, or otherwise infringe upon any third party's or prize provider's personal or intellectual property rights or contain disparaging remarks about other people or companies; (d) are inconsistent with the positive images and/or goodwill to which the Sponsors wish to associate, as determined by the Sponsors, in their sole and absolute discretion; and/or (e) otherwise violate the terms of any of the agreements that each Prize Winner has agreed to comply with as an entrant of this Sweepstakes.

Except where prohibited by law, in consideration for being awarded a prize, the Prize Winner hereby agrees and consents, without further authorization, compensation or remuneration of any kind, to the use of the Prize Winner's name, voice, biographical material, image, likeness, information submitted with the Entry Form, and/or other Sweepstakes entry content, in all forms of media and by all manners (now and hereafter known), worldwide, in perpetuity, in any and all advertising, Sweepstakes and other publicity conducted by the Sponsors or the NBA Entities. Entrants agree not to issue any publicity concerning the Sponsors or the NBA Entities. The Prize Winner and/or guest may be required to execute a release of liability, publicity releases, and/or an affidavit affirming his/her eligibility to enter and win and that he/she agrees to all terms and conditions of the Sweepstakes, and other documentation reasonably requested by the Sponsors (collectively, the "Required Documentation"); failure to execute such Required Documentation if requested will result in ineligibility for any prize and another Prize Winner will be selected.

6. Odds of Winning. Odds of becoming the Prize Winner are dependent on the total number of eligible entries received during the Entry Period. There will be one (1) Prize Winner selected from among all valid entries received during the Entry Period, as described in Section 2 above.
7. Liabilities and Dispute Resolution. By entering the Sweepstakes, each entrant agrees (a) that the Sponsors maintain the right to decide all matters and disputes arising from the Sweepstakes, that the Sponsors' determination of the Prize Winner will be final and binding and (b) to hold harmless and indemnify the Sponsors, and the NBA Entities from and against any and all liabilities, expenses, claims, damages, or causes of actions (however named or described, whether alleged or actual), with respect to or arising out of or relating to: (i) the entrant's participation in the Sweepstakes, including, but not limited to, personal injury, death and/or property damage, as well as claims based on publicity rights, defamation and/or invasion of privacy; (ii) the delivery, misdelivery, acceptance, possession, use of, misuse of, or inability to use any prize (including any type or manner of costs or damages), whether under a theory of contract, tort (including negligence), warranty, or any other theory; and (iii) travel to or from any Sweepstakes-related activity. By entering the Sweepstakes or accepting a prize, the Prize Winner agrees that the Sponsors and the NBA Entities will have no liability and will be held harmless by the Prize Winner for any and all liabilities, losses, injuries, or damages to property or to person, including death, due in whole or in part, directly or indirectly, by reason of the acceptance, participation in, use or misuse of the prize or participation in the Sweepstakes, even if caused or contributed to by the negligence of the Sponsor, or the NBA Entities.
8. Identification of Prize Winner. 9. Disputes. THE SWEEPSTAKES IS VOID WHERE PROHIBITED BY LAW. By entering the Sweepstakes, each entrant agrees that to the extent maximum permitted by applicable law: (a) any and all disputes, claims and causes of action arising out of or connected with the Sweepstakes or any prize awarded, will be resolved individually, without resort to any form of class action; and (b) entrant hereby knowingly and expressly waives all rights to seek, punitive, incidental, exemplary, indirect, consequential or special damages, lost profits, and/or any right to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of entrants and the Sponsor in connection with the Sweepstakes will be governed by and construed in accordance with the internal laws of the Commonwealth of Massachusetts, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's laws. The forum and venue for any dispute shall be in Massachusetts.
10. Privacy. Personally identifiable information that is submitted by entrants as part of the Sweepstakes will solely be used to administer the Sweepstakes, select the Prize Winner, and fulfill the prize, and will be treated in accordance with the privacy policy accessible at http://www.nba.com/news/privacy_policy.html.

12. Role of Sponsor. This Sweepstakes is not administered by JetBlue.
13. Miscellaneous. The invalidity or unenforceability of any provision of these Official Rules or the Required Documentation will not affect the validity or enforceability of any other provision. In the event that any provision of the Official Rules or the Required Documentation is determined to be invalid or otherwise unenforceable or illegal, the other provisions will remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained therein. The Sponsors' failure to enforce any term of these Official Rules will not constitute a waiver of that or any other provision. Each entrant agrees to waive any rights to claim ambiguity of these Official Rules. Headings are solely for convenience of reference and will not be deemed to affect in any manner the meaning or intent of the documents or any provision hereof. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in any Sweepstakes-related materials, privacy policy, or terms of use on the Entry Website and/or the terms and conditions of the Official Rules, the Official Rules will prevail, govern, and control, and the discrepancy will be resolved in the Sponsors' sole and absolute discretion.
