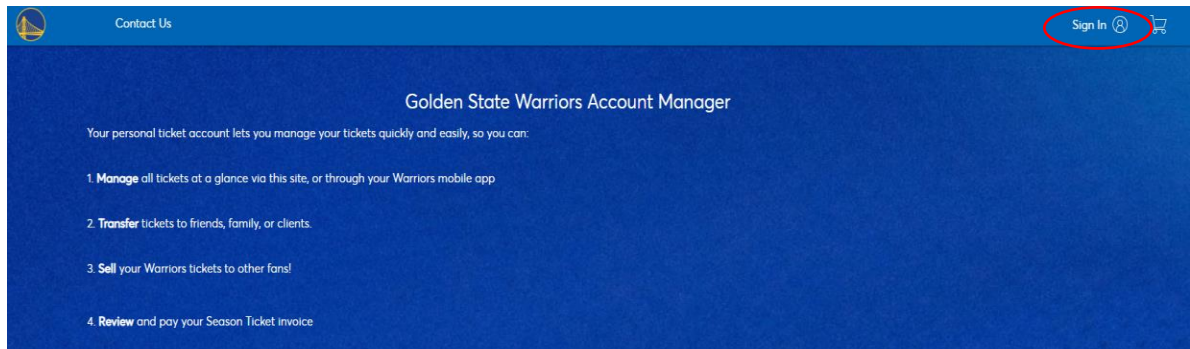


How to Access Resale History Through Your My Warriors Account

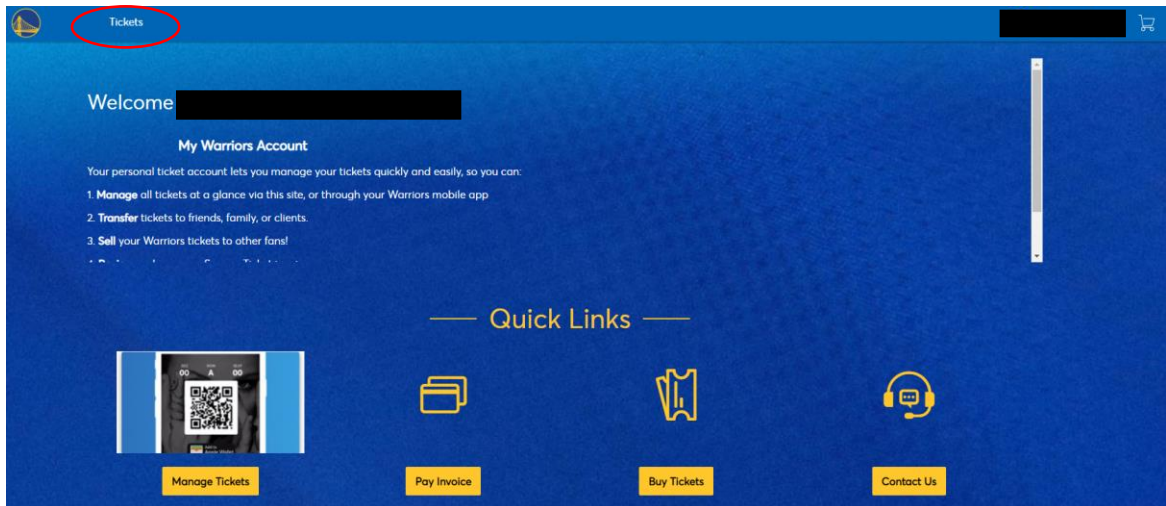
STEP 1

- Sign into your My Warriors Account at the link here: <https://am.ticketmaster.com/warriors>



STEP 2

- Once signed in, click on Tickets in the upper left-hand corner of the screen.



STEP 3

- Click on the My Listings link in the right-hand corner of your screen. Located under the blue transfer button.
