

NY KNICKS “LETTERS TO TEAM” SWEEPSTAKES (the “Sweepstakes”)

OFFICIAL RULES

**NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.
A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

1. **PERIOD:** Sweepstakes begins at 11:45 p.m. Eastern Time (“ET”) on May 2, 2024 and ends at 11:59 p.m. ET on May 7, 2024 (the “Sweepstakes Period”).
2. **ELIGIBILITY:** Sweepstakes is open to legal U.S. residents of New York, New Jersey and Connecticut, at least eighteen (18) years old at time of entry and who reside within a 150-mile radius of the arena at Madison Square Garden. Sweepstakes is void outside the area stated herein and where prohibited by law. Directors, employees, and the immediate family (spouses, parents, siblings, children, grandparents or grandchildren and their respective spouses, regardless of where they reside) and/or household members of individuals, whether or not related, employed by New York Knicks, LLC (the “Knicks” or “Sponsor”), MSG Sports, LLC, MSG Entertainment Holdings, LLC (MSG Sports, LLC and MSG Entertainment Holdings, LLC are collectively referred to herein as “MSG”), Wit Labs, Inc. (“Wit”), the National Basketball Association (the “NBA”), the NBA Member Teams, NBA Media Ventures, LLC, NBA TV, LLC, and NBA Enterprises, LLC (collectively, the “NBA Entities”) and, for all of the foregoing, all of their respective parents, subsidiaries, affiliates, directors, officers, employees, advertising and promotional agencies, are ineligible to participate. Sweepstakes is subject to all applicable MSG, Wit, NBA Entities, Sponsor, federal, state and local laws, policies and guidelines. Official Rules are subject to change at Sponsor’s sole discretion. By entering, each entrant agrees to be bound by these Official Rules and the decisions of the Sponsor, which are final and binding on all matters.
3. **TO ENTER:** To enter the Sweepstakes, during the Sweepstakes Period, visit the following link, <https://web.witcontests.com/knicks/artwall/new-york-forever-fan-gallery-240502>, and follow the instructions to complete and thereafter submit the entry form in its entirety. Limit one (1) entry per person. Multiple entries from any person will be void. Entries generated by script, macro or other automated means or by any means which subvert the entry process are void. Any attempt by an entrant to submit multiple entries by using multiple/different email addresses, phone numbers, identities, registrations, logins or any other methods will void such entrant’s entries and that entrant may be disqualified. All entries become the property of Sponsor and will not be acknowledged or returned.
4. **SELECTION OF WINNERS:** Sponsor will randomly select two (2) potential winners after the Sweepstakes Period from among all eligible entries (each a “Potential Winner”). Each Potential Winner will be notified by mobile phone or email (depending on method of entry). Each Potential Winner must comply with all terms and conditions of these Official Rules, and winning a prize is contingent upon fulfilling all requirements. Each Potential Winner (or the parent or legal guardian of such Potential Winner if applicable) may be required to sign and return an Affidavit of Eligibility, W-9 Form and Liability/Publicity Release within twenty-four (24) hours of the date of notice in order to claim his/her/their prize and become an official winner (each an “Official Winner”). If a prize or prize notification is returned as undelivered, prize remains unclaimed, a Potential Winner cannot be contacted, fails to sign and return the Affidavit of Eligibility, W-9 Form and Liability/Publicity Release within the required time period or is not in compliance with these Official Rules, such Potential Winner may be disqualified and forfeits the prize. In the event that a Potential Winner is disqualified for any reason, Sponsor may award the prize to an alternate Potential Winner by random drawing from among all remaining eligible entries received. PRIZE (2): Each Official Winner will receive two (2) tickets to one (1) New York Knicks' 2023-24 NBA playoff game, subject to availability and with all details to be determined (as between Sponsor and Official Winners) by Sponsor. Total Approximate Retail Value ("ARV") of all the Prizes: \$1,200.

Tickets (if applicable) are subject to terms and conditions stated thereon. Each Official Winner, and his/her/their accompanying guest, agree to comply at all relevant times with all MSG, NBA Entities, federal, state, city, and local rules, regulations, guidelines, policies and laws, as may change from time to time, as may be requested or required by MSG. Failure to do so may result in forfeiture of the prize.

Transportation to/from the event(s) is not included as part of the prize. Prize is awarded "as is" with no warranty or guarantee, either express or implied. Wit, on behalf of Sponsor, performs the collection, submission, and/or processing of entrant entry forms for the Sweepstakes, as well as the overall administration of the Sweepstakes. Due to the variable nature of the number of prizes and entrants in the Sweepstakes, Wit's backend engine utilizes a dynamic probability function to determine winners, based on an expected number of eligible entries. Therefore, the probability of winning a prize may vary throughout the course of the Sweepstakes Period. The number of prizes available and the number of eligible entries received affect the odds of winning. If applicable, some prizes may be left unawarded at the end of the Sweepstakes Period if there are fewer eligible entries than expected. Sponsor reserves the right to award such remaining prizes, if applicable, to eligible entrants chosen at random.

PUBLICITY: Except where prohibited, participation in the Sweepstakes constitutes each Official Winner's (and the parent or legal guardian of such Official Winner if applicable) consent to Sponsor, Wit, MSG, the NBA Entities and their respective parent, subsidiary and affiliated companies and their designees to use his/her/their name, likeness, photograph, voice, opinions, biographical information, hometown and state for advertising and promotional purposes, in any manner, in any and all media, now or hereafter devised, worldwide in perpetuity, without further payment or consideration, notification or permission.
