

NY Knicks x Wellball Competition
presented by DoorDash
(the “Competition”)

OFFICIAL RULES

ELIGIBILITY: Competition is open to legal residents of the United States, 10 years of age or older as of April 12, 2025, who are not current collegiate or professional basketball players. Void outside the area stated and where prohibited. An eligible minor must have a parent’s or legal guardian’s permission to participate. Employees and other workers, including temporary employees, freelancers and independent contractors, of MSG Sports, LLC, New York Knicks, LLC (“Knicks” or “Sponsor”), the National Basketball Association and its member teams and NBA Properties, Inc. (collectively, “NBA Entities”), Basketball City New York, LLC, The Basketball Shot Club LLC, and DoorDash, Inc., and all of their respective parents, subsidiaries, affiliates and advertising and promotion agencies, and their immediate families (parent, child, spouse or sibling and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related) of such individuals are not eligible. By participating, participants (and, if eligible minors, their parents or legal guardians) agree to be bound by these Official Rules and the decisions of Sponsor and judges, which are binding and final on matters relating to this Competition. Competition is subject to all applicable federal, state and local laws.

REGISTRATION: Visit [Knicks.com/wellball](https://knicks.com/wellball) and follow the directions to register to participate in the Competition in one of the following divisions: Adult Division, Youth Division, or 1v1 Division (each, a “Division”). There are only 48 spaces available in each Division. If you are registering to participate in the “Adult Division,” your team must be composed of 3-4 players who are 18 years of age or older as of the Competition start date; a \$100 fee must be paid a time of registration which will include Competition jerseys for each team member. If you are registering to participate in the “Youth Division,” your team must be composed of 3-4 players who are between 10 and 14 years of age as of the Competition start date; a \$100 fee must be paid a time of registration which will include Competition jerseys for each team member. If you are registering to participate in the 1v1 Division, you must be 18 years of age or older as of the Competition start date; a \$50 fee must be paid a time of registration which will include a Competition jersey for such participant. For the avoidance of doubt, an individual cannot participate in both the Adult Division and the 1v1 Division. At time of Competition check-in, all players will be required to provide a signed Competition Waiver (incorporated herein by reference). A Youth Division team must be accompanied by an individual 18 years of age or older and such individual must provide a Competition Waiver signed by each player’s parent or legal guardian. Competition Waivers will be sent to participants in advance of the Competition and/or at the Competition venue at time of registration. Registrations will be accepted through 3:00 PM ET on April 9, 2025 or while spaces in a Division remain available. Registrations will be accepted in a first come, first served basis. Sponsor does not guarantee that everyone who wishes to participate will have an opportunity to do so.

COMPETITION PLAY: All individual players and team members must check-in by 9:00 AM ET on April 12, 2025 or such other time as directed by Sponsor; individual players or team members who arrive after such check-in time may be disqualified in Sponsor’s sole discretion. The Competition brackets for each Division will be randomly determined by Sponsor. The Competition will be governed by the Knicks x Wellball Competition Rules (incorporated herein by reference). Sponsor’s and on-site referees’ and judges’ decisions with respect to the Competition are final and binding.

PRIZES: Adult Division: \$5,000 (to be divided equally between all players on the winning team). **1v1 Division Prize:** \$1500. **Youth Division Prize:** a Knicks gift bag for each player on the winning team, each such gift bag a \$100 value. Prizes are awarded “as is” with no warranty or guarantee, either express or implied. Winners will be responsible for all federal, state and local taxes; each player who wins the Adult Division or 1v1 Division Prize will be required to complete an IRS W-9 Form and will be issued a 1099 for the prize amount. No substitution, transfers, or cash equivalent of a non-cash prize, is permitted, except at the sole discretion of Sponsor. Sponsor may substitute a prize of comparable or greater value. All prize details are at Sponsor’s sole discretion. Limit one (1) prize per person.

GENERAL CONDITIONS: Sponsor reserves the right to cancel or modify the Competition (or any portion thereof) if fraud or any other factor impairs the integrity of the Competition, as determined by Sponsor in its sole discretion. In such event, Sponsor reserves the right to award the prizes as otherwise fair and appropriate by Sponsor. Sponsor reserves the right in

its sole discretion to disqualify any individual and/or team it finds to be tampering with the operation of the Competition or to be acting in violation of these Official Rules, or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Competition is a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages (including attorneys' fees) and other remedies from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

RELEASE/LIMITS OF LIABILITY: By entering this Competition, each participant (and, if an eligible minor, their parent or legal guardian) agrees to release and hold harmless MSG Sports, LLC, Knicks, the NBA Entities, Basketball City New York, LLC, The Basketball Shot Club LLC, and DoorDash, Inc., and their respective parents, affiliates, subsidiaries, officers, directors, shareholders, agents, employees, representatives, and all others associated with the development and execution of this Competition (collectively, "Released Parties") from and against any injuries, losses, damages, rights, claim or cause of action of any kind arising, in whole or in part, directly or indirectly, out of participation in the Competition (including any injuries sustained during the Competition or travel or activity related thereto) or resulting, directly or indirectly, from acceptance, possession, use, or misuse of any prize awarded in connection with the Competition, including without limitation personal injury, death, and/or property damage, as well as claims based on publicity rights, defamation, and/or invasion of privacy. Released Parties are not responsible for lost, late, incomplete, inaccurate, stolen, or damaged registrations, emails, or other communications of any kind; lost, interrupted or unavailable network, server, Internet Service Provider ("ISP"), website, or other connections; availability or accessibility or miscommunications; failed computer, satellite, telephone or cable transmissions, lines, or technical failure; jumbled, scrambled, delayed, or misdirected transmissions; computer hardware or software malfunctions, failures or difficulties; or errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Competition, including, without limitation, errors or difficulties which may occur in connection with the administration of the Competition, the announcement of the prizes, or in any Competition-related materials. Persons who tamper with or abuse any aspect of the Competition, who act in an unsportsmanlike or disruptive manner, or who are in violation of these Official Rules, as solely determined by Sponsor, will be disqualified. Should any portion of the Competition be, in Sponsor's sole opinion, compromised by virus, worms, bugs, non-authorized human intervention or other causes which, in the sole opinion of the Sponsor, corrupt or impair the administration, security, fairness or proper play, Sponsor reserves the right at its sole discretion to suspend, modify or terminate any Competition. CAUTION: ANY ATTEMPT TO DELIBERATELY DAMAGE THE WEBSITE OR UNDERMINE THE LEGITIMATE OPERATION OF THE COMPETITION MAY BE IN VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES AND OTHER REMEDIES (INCLUDING ATTORNEYS' FEES) FROM ANY SUCH INDIVIDUAL TO THE FULLEST EXTENT OF THE LAW, INCLUDING CRIMINAL PROSECUTION.

Entrants who provide their email address will automatically be enrolled to receive emails from or on behalf of Sponsor or others and can opt out of receiving future emails at any time by following the directions provided in such emails.

DISPUTES: Each participant (and, if an eligible minor, their parent or legal guardian) agrees that: (i) any and all disputes, claims and causes of action arising out of or connected with this Competition, or any prizes awarded, shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the District of New York or the appropriate New York State Court located in New York; (ii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Competition but in no event attorneys' fees; and (iii) under no circumstances will participants be permitted to obtain awards for and participants hereby waive all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO EVERY PARTICIPANT.
