

VIRTUAL T-SHIRT TOSS PRESENTED BY RUSHORDERTEES

Important: Please read these Official Rules before entering this Sweepstakes (the “Sweepstakes”).
By participating in this Sweepstakes, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements below.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

Sweepstakes void where prohibited by law. Subject to applicable federal, state, and local laws.

1. Eligibility: The Sweepstakes is open only to legal residents of the 50 United States or District of Columbia, excluding Florida and New York, who are at least 18 years old (or the age of majority in their jurisdiction of residence, whichever is older) at the time of entry.

2. “Second” Virtual Toss starts at 10:00AM ET on November 22, 2023 and ends at 7:00PM ET on November 22, 2023.
3. “Third” Virtual Toss starts at 10:00AM ET on December 16, 2023 and ends at 7:00PM ET on December 16, 2023.
4. “Fourth” Virtual Toss starts at 10:00AM ET on December 30, 2023 and ends at 7:00PM ET on December 30, 2023.
5. “Fifth” Virtual Toss starts at 10:00AM ET on January 10, 2024 and ends at 7:00PM ET on January 10, 2024.
6. “Sixth” Virtual Toss starts at 10:00AM ET on January 29, 2024 and ends at 7:00PM ET on January 29, 2024.
7. “Seventh” Virtual Toss starts at 10:00AM ET on February 10, 2024 and ends at 7:00PM ET on February 10, 2024.

8. "Eighth" Virtual Toss starts at 10:00AM ET on February 27, 2024 and ends at 7:00PM ET on February 27, 2024.
9. "Ninth" Virtual Toss starts at 10:00AM ET on March 12, 2024 and ends at 7:00PM ET on March 12, 2024.
10. "Tenth" Virtual Toss starts at 10:00AM ET on April 4, 2024 and ends at 7:00PM ET on April 4, 2024.

LIMIT OF ONE (1) ENTRY PER PERSON DURING EACH APPLICABLE CHALLENGE.

3. How to Enter: To enter, during the Sweepstakes Period visit www.x.com/sixers and log-in or join X (formerly Twitter) (joining X is free). Repost the post from @Sixers promoting the Virtual T-Shirt Toss presented by RushOrderTees (repost on your X account must be publicly viewable during the Sweepstakes Period). Upon completion of these steps, you will receive one entry into the Sweepstakes. Limit one (1) entry per person during Sweepstakes Period. Any attempts to obtain additional entries, including through multiple or duplicate accounts will result in disqualification.

- a. Free Method of Entry: Mail a 3 x 5 card with your name, address, and email address to Sponsor's address listed in Section 15 below. P.O. Boxes are not permitted. Entries must be postmarked on the last day of the entry period and will be honored if received up to three (3) days after the end of the entry period.

If participating in this Sweepstakes via your mobile device (which service may only be available via select devices and participating wireless carriers and is not required to enter), you may be charged for standard data use from your mobile device according to the terms in your wireless service provider's data plan. 8. "Eighth" Virtual Toss selection on or about March 2, 2024.
9. "Ninth" Virtual Toss selection on or about March 16, 2024.
10. "Tenth" Virtual Toss selection on or about April 8, 2024.

To the fullest extent permitted by applicable law, Sponsor may require each potential winner to sign and return, as specified by Sponsor, an Affidavit of Eligibility and Liability/Publicity Release in order to claim his/her prize. If (i) the attempted notification is returned as undeliverable without a forwarding address or the potential winner does not respond within 24 hours of being notified by Sponsor; (ii) any required documents are not returned as specified by Sponsor, such as the Affidavit of Eligibility and Liability/Publicity Release; or (iii) if potential winner is otherwise unable to accept the prize as stated, the prize will be forfeited and may be awarded to an alternate winner.
