

**Enter to Win Spurs Sports and Entertainment – Social Media Giveaway Sweepstakes: Official Rules**

1. "Social Media" or "Social Media Platform" refers to Instagram, Twitter, Facebook, Tiktok, and/or YouTube.
2. No purchase necessary to enter or win. Limit one Entry (defined below) per person and or per e-mail address.

All entries must be received by the ending date and time also referenced in the related Post (the "Deadline") to be eligible.
