

Detroit Pistons Ron and Ausar X Sweepstakes
Official Rules and Regulations

1. DEFINED/IMPORTANT TERMS

- a. ***The “Sweepstakes”***: Detroit Pistons Ron and Ausar X Sweepstakes.
- b. ***“Sponsor” or “DPBC”***: Detroit Pistons Basketball Company, LLC, 6201 2nd Ave., Detroit, MI 48202.
- c. ***“Start Date”***: ***September 9th***, 2026, at 12:00 am Eastern Time (“ET”).
- d. ***“End Date”***: ***September 10th***, 2026, at 11:59 am ET.
- e. ***“Authorized Account Holder”***: The “authorized account holder” of a Mode of Entry, is the natural person assigned a Mode of Entry by an Internet access provider, online service provider, telecom service provider, social media platform, or other organization responsible for assigning email addresses, phone numbers, or social media accounts for the domain associated with the submitted address.
- f. ***“Entrant(s)”***: “Entrants” must enter the Sweepstakes via the Mode of Entry and be (i) the Age of Eligibility or older; and (ii) a legal resident of the United States.
 - i. Employees of DPBC, Little Caesars Arena (“LCA”), Palace Sports and Entertainment, LLC (“PSE”), the National Basketball Association (“NBA”), its member teams, NBA Properties (NBA and WNBA), Olympia Entertainment Events Center, LLC (“Olympia”) and their respective subsidiaries, agents’ affiliates, franchisees, licensees, dealers, advertising and promotion agencies, event co-promoters, and immediate family members of such employees, shall not be considered Entrants and are not eligible to win.
- g. ***“Mode of Entry”***: Shall enter by (i) following the official Detroit Pistons X page, tag another user on the designated post, and repost the designated post; or (ii) entering you information as prompted on the sign-up sheet.
- h. ***Entry Process***: To enter, Entrants must either: (a) (i) follow the Detroit Pistons on X (@detroitpistons), (ii) tag another user on the designated post, and (iii) repost the designated post; or (b) enter all required information as prompted on the sign-up sheet. The designated post will be made available on the official Detroit Pistons X page on or before the Start Date. Entrants must remain a follower of the official Detroit Pistons X page and keep all engagement with the designated post posted on X until after the Drawing Date to remain eligible for the Prize.
- i. ***Entry Location/URL***: Detroit Pistons on X (@detroitpistons) or <https://forms.pistons.com/1440>.
- j. ***Number of Potential Winners***: One (1) winner.
- k. ***“Drawing Date(s)”***: ***Thursday***, September 10th, 2026, at 12:00 pm ET.
- l. ***“Notification Method”***: potential prize winner will be notified by email, text message, U.S. mail, telephone, or private delivery service (at Sponsor’s sole discretion). Winner’s age is subject to independent age verification, and if failed, will result in prize forfeiture. In the event of noncompliance, if the prize winner cannot be reached at the phone number, email address or address on that winner’s entry, or if the Prize or Prize notification is returned unclaimed or undeliverable for whatever reason beyond the control of Sponsor, that Prize will be forfeited, and an alternate winner may be selected only if time permits and in Sponsor’s sole discretion.
- m. ***“Prize”***: One (1) Ron Holland II Autographed Basketball, one (1) Ausar Thompson Lithographic, or other Prize of equal or greater value as determined by DPBC in its sole discretion.
- n. ***“Prize Estimated Retail Value”***: One-hundred dollars (\$100.00).
- o. ***Age of Eligibility***: Entrants must be 18 years of age or older.

2. **TO ENTER: NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.** All federal, state and local laws and regulations apply. Void where prohibited by law. The Sweepstakes runs from the Start Date until the End Date, Eastern Time. To enter, Entrants must complete the Mode of Entry, and which is available at the Entry Location/URL. One entry per person per account. All entries must be received by DPBC by the End Date to be considered for entry. DPBC’s computer is the official time keeping device for the Sweepstakes. Any attempt by any Entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, and/or registrations or any other methods will void that Entrant’s entries and that Entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. DPBC is not responsible for late, undelivered, misaddressed, ineligible, misdirected, illegible, incomplete, or incorrect entries, and has sole discretion on determining ineligible entries. DPBC reserves the right to cancel, suspend and/or modify the Sweepstakes at any time. In the event of a dispute as to any registration or entry, the Authorized Account Holder of the Mode of Entry used to register will be deemed to be the Entrant.

3. **CONDITIONS OF ENTRY**: By submitting an entry, Entrants are agreeing to the rules (“Official Rules”) of the

4. **DRAWING AND NOTIFICATION:** The number of potential winner(s) denoted in Section 1 will be randomly selected from all eligible entries on the Drawing Date. The drawing will be conducted by DPBC, whose decisions are final and binding. The odds of winning are solely dependent upon the number of eligible entries. Potential winners will be notified by the Notification Method. If any potential winner cannot be reached after a reasonable effort has been exerted, if he/she is found to be ineligible, or if he/she cannot or does not comply with these Official Rules, such potential winner will be disqualified and an alternate potential winner may be selected from all remaining eligible entries, time permitting and at sole discretion of DPBC. All Prizes must be claimed within 48 hours of initial notification by DPBC. Unclaimed Prizes will not be awarded. DPBC's decisions on all matters relating to this Sweepstakes are final. Non-compliance with these rules may result in disqualification, and an alternate winner may be selected.

5. **PRIZE DETAILS:** Each potential winner will receive a Prize (as defined in Section 1). The Prize Estimated Retail Value is designated in Section 1. Any other expenses not mentioned will be the responsibility of each winner. Limit one Prize per person, no Prize substitution or cash redemption allowed by winner, except at DPBC's sole and absolute discretion. DPBC reserves the right to substitute prizes of equal or greater value as necessary. All Prizes are non-transferable. All taxes and other expenses incurred in connection with any other aspect of the Prizes are the sole responsibility of each winner. If applicable, Prize is subject to all Pistons ticket terms and conditions and any tickets provided as part of the Prize shall be subject to availability; the location and specific game of such tickets shall be determined by DPBC.
6. **CONDITIONS, RESTRICTIONS AND LIMITATIONS OF LIABILITY:** All entries become the property of DPBC and will not be acknowledged or returned. By submitting an entry, Entrants agree (i) to abide by and be bound by these Official Rules and the decisions of DPBC, which shall be final and binding; (ii) to DPBC's use of their names and/or likenesses, photographs, voice, opinions, and/or hometown and state for advertising and publicity purposes in any media, worldwide, without additional compensation, unless prohibited by law; and (iii) to release, discharge, and hold harmless PSE, DPBC NBA, its member teams, NBA Properties, Inc., LCA, Olympia and their respective parent companies, franchisees/licensees, affiliates, subsidiaries, agents, award supplier, and their respective officers, directors, employees, agents, and representatives ("**Released Parties**") from and against any and all liability arising out of or related to any Prize received in this Sweepstakes or from participating in this Sweepstakes or any Prize-related activities, including, but not limited to, personal injury, death, or damage to or loss of property, or receipt or use or misuse of any aspect of the Prize. Entrants waive the right to assert, as a cost of receiving Prize, any and all costs of redemption. Any disputes relating to this Sweepstakes shall be governed by the laws of the State of Michigan and venue for any such dispute shall be Wayne County, Michigan.
7. **GENERAL CONDITIONS:** DPBC reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, if any fraud, technical failures, human error or any other factor impairs the integrity or proper functioning of the Sweepstakes, as determined by DPBC in its sole discretion. In such event, DPBC, in its sole discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for any or all of the Prizes offered herein. DPBC reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, DPBC reserves the right to seek damages from any such person to the fullest extent permitted by law. DPBC's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. A winner must not be under any legal impediment that would prevent a winner from accepting the Prize, and must be able to participate in the Sweepstakes and accept the Prize on the date or dates specified by DPBC. Otherwise, the Prize will be forfeited.
8. **LIMITATIONS OF LIABILITY:** The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by Entrants, printing errors or by any of the equipment or programming associated with or utilized in the Sweepstakes; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in cellular networks, phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Sweepstakes; (4) technical or human error which may occur in the administration of the

Sweepstakes or the processing of entries; (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from Entrant's participation in the Sweepstakes or receipt or use or misuse of any Prize; or (6) any inability to conduct the Sweepstakes or award the Prize as a result of any act of God, labor stoppage strike, or lock out, or other reason beyond the control of the Released Parties. If for any reason an Entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, Entrant's sole remedy is another entry in the Sweepstakes, if it is possible. No more than the stated number of Prizes will be awarded. In the event that production, technical, seeding, programming or any other reasons cause more than the stated number of Prizes as set forth in these Official Rules to be available and/or claimed, DPBC reserves the right to award only the stated number of Prizes by a random drawing among all legitimate, unawarded, eligible Prize claims.

9. **DISPUTES.** Entrant agrees that: (i) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes, or any Prizes awarded, shall be resolved individually, without resort to any form of class action, and exclusively by, the appropriate State of Michigan Court located in Wayne County, Michigan (ii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (iii) under no circumstances will Entrant be permitted to obtain awards for, and Entrant hereby waives all rights to claim, any punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. **SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU.** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the Entrant and DPBC in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Michigan, without giving effect to any choice of law or conflict of law rules, which would cause the application of the laws of any jurisdiction other than the State of Michigan. Entrant hereby waives any right to trial by jury in any such action or proceeding.
